THEFT		
<ul style="list-style-type: none"> • Involving Break in 	<ul style="list-style-type: none"> • Call detachment, RCMP will attend ASAP 	<ul style="list-style-type: none"> • Call detachment immediately, follow up with suspension / expulsion letter
<ul style="list-style-type: none"> • Under \$5,000 	<ul style="list-style-type: none"> • Discretionary – call if event needs solving 	<ul style="list-style-type: none"> • Parents have right to press charges, inform detachment
FIGHTING		
<ul style="list-style-type: none"> • Willing combatants 	<ul style="list-style-type: none"> • Call if injuries are severe, RCMP will attend at school or hospital 	<ul style="list-style-type: none"> • Call 911 if injuries severe, follow up with suspension / expulsion letter
<ul style="list-style-type: none"> • One party unwilling 	<ul style="list-style-type: none"> • Call if injuries are severe, RCMP will attend at school or hospital 	<ul style="list-style-type: none"> • Call 911 if injuries severe, follow up with suspension / expulsion letter • Parents have right to press charges

VANDALISM/ MISCHIEF		
<ul style="list-style-type: none"> • Damage to school or property 	<ul style="list-style-type: none"> • Discretionary – call if event needs solving or if damage is high 	<ul style="list-style-type: none"> • Copy on suspension letter
NON CONSENSUAL DISTRIBUTION OF SEXUAL IMAGES		
<ul style="list-style-type: none"> • If you suspect an adult is involved with a minor, this is criminal matter. • If the nonconsensual sharing is between teens, see self/per exploitation flow chart 	<ul style="list-style-type: none"> • Call detachment, member will attend • Detain youth with images on phone • Ask student to turn over phone (to prevent spread of image and to retain image in event it is required by police) • If police request phone, it is to be turned over 	<ul style="list-style-type: none"> • Call detachment • Email to Cybertip.ca to report/consult / ask questions
BULLYING		
<ul style="list-style-type: none"> • If one party fears for their safety, or there is a pattern of escalating behavior 	<ul style="list-style-type: none"> • Call detachment member may meet with aggressor to de-escalate behavior 	<ul style="list-style-type: none"> • Copy on suspension letter
THREATS		
<ul style="list-style-type: none"> • Of immediate harm to self or others 	<ul style="list-style-type: none"> • Call 911, member will attend 	<ul style="list-style-type: none"> • Involve in Threat Assessment as necessary
WEAPONS		
<ul style="list-style-type: none"> • Pocket knife, possession, no intent to harm • Possession Weapon or Imitation weapon • Threat of use 	<ul style="list-style-type: none"> • Discretionary call • Call 911 • Call 911 	<ul style="list-style-type: none"> • No correspondence necessary • Call detachment immediately, follow up with suspension / expulsion letter. • RCMP may be required in the development of a safety plan and its enforcement

CUSTODY		
<ul style="list-style-type: none"> • Parent requests school enforce custodial arrangements – • Parent provides document limiting access of parent due to safety concerns (ie protection order) 	<ul style="list-style-type: none"> • Police will attend only if there is a court document advising of a breach (will not otherwise attend for situations related to who has custodial access at that time) • Police will attend if required to keep the peace • Call 911 - Police will attend 	
POLICE REQUIRE INTERVIEW		
<ul style="list-style-type: none"> • Police officer requests an interview of student at the school 	<ul style="list-style-type: none"> • If there is an interview that is determined to be required during the day, school staff is to call parent to attend. If parent cannot attend, principal may stand in for parent. • Interviews that are not urgent in nature are to occur off school property (see 1.B.50 Police Interview Admin Procedure) 	<ul style="list-style-type: none"> • Police officer to call parent and school in advance of requested interview if possible.
MENTAL HEALTH		
<ul style="list-style-type: none"> • School asks for help regarding student who is violent or out of control 	<ul style="list-style-type: none"> • Call 911
