Toward a Knowledge-Rich Future

In Evergreen, we're shifting toward something powerful: a knowledge-rich approach to teaching and learning.

3. Interventions Teacher PLC

Our most recent meeting of Interventions Teacher PLC was held last week, and we were happy to welcome two staff members from Peguis – our relationship with the school in Peguis includes their participation in our early literacy learning and assistance that we receive from them re: land-based education.

4. Instructional Leadership

Our Leadership Development program participants recently had their second training session with Zach Groshell in support of enhancing our understanding of and capacity to provide feedback to teachers on the Core Strategies of *My Evergreen Classroom*.

Our Principals recently had an online training session with Rachel Sewell from StepLab on using the StepLab digital platform for "drop ins" – a quick way to provide precise positive feedback to teachers after walk-throughs re: our core instructional strategies.

5. Research Ed Canada - Halifax

A team of teachers, school and division leaders attended Research Ed in Halifax last weekend. It was an excellent learning experience for all of us, and our staff also delivered two presentations on our work:

- Paul Bailey and Lisa Michaluk presented on '4 years of transformation at SSES in literacy instruction and intervention.'
- II. Crystal MacDonald, Della Magnusson, and Jess Worden presented on 'My Evergreen Classroom and Evidence-based teaching strategies'

An additional highlight for me as a participant was a presentation by Dr. George Georgeiou from the Faculty of Ed at University of Alberta. Dr. Georgeiou has led some research that highlights the inconsistency and inadequacy of teacher pre-service training re: structured literacy.
