**BEING A BY-LAW** of the Evergreen School Division to establish the boundaries to the wards and the number of trustees in the Evergreen School Division.

**WHEREAS** by virtue of Section 57(1), subject to Subsection (2), (3), (4), (5) and (6) of The Public Schools Act, being Chapter P. 250 of the Revised Statutes of Manitoba, the Board of Trustees of the Evergreen School Division may pass a By-law to increase/decrease the number of wards and increase/decrease the number of trustees in the Evergreen School Division.

**NOW THEREFORE** the Board of Trustees of the Evergreen School Division, duly assembled, enact as follows:

1. That the Evergreen School Division maintain three (3) wards which are comprised of lands set out as follows:

**a) WARD 1**

Sections 9-15, 22-29, 32-36 – 20 – 1EPM; sections 7-10, 13-36 - 20 – 2EPM; sections 18-20, 29-33 – 20 – 3EPM; all township 21 – 1EPM; all township 21 – 2EPM; sections 4-9, 16-36 – 21 – 3EPM; sections 19-22, all that portion of sections 23, 26 and 27 not covered by the waters of Lake Winnipeg, sections 28-32, all 33 and 34 not covered by the waters of Lake Winnipeg – 21 – 4EPM; NE ¼ 25, SE ¼ 36 – 22 – 1WPM; Sections 1-5, 8-17, 20-29, N ½ and SE ¼ 30, 31-36 – 22 – 1EPM; all township 22 – 2EPM; all township 22 – 3EPM; all that portion of section 4 not covered by the waters of Lake Winnipeg, sections 5-8, all that portion of sections 9 and 16 not covered by the waters of Lake Winnipeg, sections 17-20, all that portion of sections 21 and 27 not covered by the waters of Lake Winnipeg, sections 28-33, all that portion of section 34 not covered by the waters of Lake Winnipeg – 22 – 4EPM; All sections 1–31, S ½ 32, S ½ 33, 34–36 - 23 – 1EPM; all township - 23 – 2EPM; all of township 23 – 3EPM; all that portion of section 2 not covered by the waters of Lake Winnipeg, sections 3-10, all that portion of sections 11 and 14 not covered by the waters of Lake Winnipeg, sections 15-21, all that portion of sections 22, 23 and 27 not covered by the waters of Lake Winnipeg, sections 28-33, all that portion of section 34 not covered by the waters of Lake Winnipeg – 23 – 4EPM; sections 1–3, E ½ 10, 11- 12, S ½ 13, NE ¼ 13, 24 - 24- 1EPM; sections 1-26, S ½ 27, 34-36 – 24- 2EPM; all township 24 – 3EPM; all that portion of section 3 not covered by the waters of Lake Winnipeg, sections 4-9, all that portion of sections 10, 11, 13 and 14 not covered by the waters of Lake Winnipeg, sections 15-23, all that portion of section 24 not covered by the waters of Lake Winnipeg, sections 25-36 – 24 – 4EPM; all that portion of sections 19, 20, 28 and 29 not covered by the waters of Lake Winnipeg, sections 30-32, all that portion of section 33 not covered by the waters of Lake Winnipeg – 24 – 5EPM; sections 1, 12, 13, 24, 25 and 36 – 25 – 2EPM; all township 25 – 3EPM; all township 25 – 4EPM not covered by the waters of Lake Winnipeg; all township 25 – 5EPM not covered by the waters of Lake Winnipeg; all township 23 – 5EPM not covered by the waters of Lake Winnipeg; all township 23 – 6EPM not covered by the waters of Lake Winnipeg; sections 1-4, all that portion of sections 5, 8, 9 and 10 not covered by the waters of Lake Winnipeg, section 11 and 12, all that portion of sections 13, 14, 24 and 25 not covered by the waters of Lake

Winnipeg – 24 – 5EPM; all township 24 – 6EPM not covered by the waters of Lake Winnipeg; all township 25 – 6EPM not covered by the waters of Lake Winnipeg; all that portion of sections 19, 30 and 31 – 25 – 7EPM not covered by the waters of Lake Winnipeg (Hecla Island Provincial Park).

**b) WARD 2**

Sections 34, 35 and N ½ 36 – 18 – 1EPM; N ½ 22, N ½ 23, NE ¼ 24, 25-27, E ½ 28, N ½ 31, N ½ and SE ¼ 32, 33-36 – 18 – 2EPM; NE ¼ 20, 21-36 – 18 – 3EPM; Sections 19, 20, all that portion of sections 21 and 28 not covered by the waters of Lake Winnipeg, 29-32, all that portion of sections 33-35 not covered by the waters of Lake Winnipeg – 18 – 4EPM; sections 1-3, 10-15, E ½ 21, 22-27, NE ¼ 28, SE ¼ 33, 34-36 – 19 – 1EPM; all township 19 – 2EPM; all township 19 – 3EPM; all that portion of sections 2-4 not covered by the waters of Lake Winnipeg, 5-8, all that portion of sections 9, 10 and 16 not covered by the waters of Lake Winnipeg, 17-20, all that portion of sections 21 and 28 not covered by the waters of Lake Winnipeg, 29-32, all that portion of sections 33 not covered by the waters of Lake Winnipeg – 19 – 4EPM; sections 1-3 – 20 – 1EPM; sections 1-6, 11-12 – 20 – 2EPM; sections 1-17, 21-28, 34-36 – 20 – 3EPM; all that portion of section 4 not covered by the waters of Lake Winnipeg, 5-8, all that portion of sections 9 and 16 not covered by the waters of Lake Winnipeg, sections 17-20, all that portion of sections 21 and 28 not covered by the waters of Lake Winnipeg, sections 29- 32, all that portion of section 33 not covered by the waters of Lake Winnipeg – 20 – 4EPM; sections 1-3, 10-15 – 21 – 3EPM; all that portion of section 4 not covered by the waters of Lake Winnipeg, sections 5-8, all that portion of sections 9, 10 and 15 not covered by the waters of Lake Winnipeg, sections 16-18 – 21 – 4EPM;.

**c) WARD 3**

Sections 10-15, 22-27, N ½ and SE ¼ 33, 34-36 – 17 – 3EPM; all that portion of sections 1 and 2 not covered by the waters of Lake Winnipeg, sections 3-5, 7-10, all that portion of sections 11 and 14 not covered by the waters of Lake Winnipeg, sections 15- 22, all that portion of sections 23 and 26 not covered by the waters of Lake Winnipeg, sections 27-33, all that portion of section 34 not covered by the waters of Lake Winnipeg – 17 – 4EPM; sections 1-4, NE ¼ 5, S ½ and NE ¼ 9, 10-16, SE ¼ 17 – 18 – 3EPM, all that portion of section 3 not covered by the waters of Lake Winnipeg, sections 4-8, all that portion of sections 9, 10 and 16 not covered by the waters of Lake Winnipeg, sections 17-18 – 18 – 4EPM.

2. That the number of Trustees to be elected for each ward are as follows:

WARD 1	2 Trustees
WARD 2	3 Trustees
WARD 3	2 Trustees
